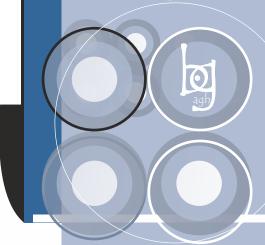

The Regional Patent Information Centre carries out IP searches for: employees and students of the AGH University of Science and Technology in Cracow, students and employees of other state universities or colleges in Cracow, patent agents, inventors and researches, representatives of small and medium enterprises (SMEs).

ORBIT

FamPat covers patent families in all disciplines. The documents are from: 95 national offices, 6 regional offices (EPO, WIPO, OAPI, ARIPO, EAPO and CCG). Utility models are also covered for 38 countries.

DERWENT INNOVATIONS INDEX

merges the value-added patent information from Derwent World Patents Index® with the patent citation information from Derwent Patent Citation Index®.

EPO GLOBAL PATENT INDEX

Global patent index (GPI) combines the EPO worldwide bibliographic data collection available in Espacenet with the detailed search capabilities offered by the Patent information services for experts.

ESPACENET

patents from the EPO, USA, France, Germany, United Kingdom and Poland, Japanese and Chinese patent abstracts, PCT Applications, patents from over 50 countries.

PATENTSCOPE

enables to do full-text search in over 1.6 million published international patent applications from the first publication in 1978)

USPTO

access to bibliographic and full-text data bases patents, trade marks; full-text patents - 1790 onwards.

ROMARIN

information on all international marks recorded under WIPO's Madrid System

TMVIEW

covering data from all the participating official trade mark Offices free of charge

HAGUE EXPRESS

industrial designs registered under the Hague System and recorded in the International Register

DESIGNVIEW

industrial designs registered in Austria, Bulgaria, Benelux, Canada, China..., Poland..., EUIPO, WIPO

LISBON EKSPRESS

information on all the appellations of origin entered, in accordance with the Lisbon Agreement for the Protection of Appellations of Origin and their International Registration, in the international register kept by the WIPO International Bureau and which are in force
